- 4. News about funding, budget, and economy:
  - ✓ There has to be an e-mail address for NordSAC, that is gmail and is accessible to all board members (Bjarne will create it).

  - ✓ Estonian Ministry of Justice has launched a document of intention for collecting opinion of the organisations (yes-model or no-model) in January 2025. The majority has supported the yesmodel --- > the law will be put together in 2025.
  - ✓ Estonia: a new SAC will be opened on the biggest island (Saaremaa), will be = 5 SACs.



- ✓ Finland: an English article manuscript is being prepared (Finnish protocol).
- ✓ Sweden: the number of patients is about the same. Improving the service locally (gynaecological emergency departments = SACs), taking care of male victims. Articles in the media.
- ✓ Helen has been to Africa Tansania a well-organized SAC, social worker has an important role, forensic evidence is collected. 25 forensic nurses will visit Norway this summer.
