News from each country

<u>Estonia</u>

The upcoming meeting in Tallin on Oct 2: The Kaljulaid seminar (https://kerstikaljulaid.ee/en/)

The meeting in Tallin is about consent law whether it should be a "yes-" or a "no-" model.



Anna has planned a 15 min talk about tonic immobility, psychological reactions, and the consent law in Sweeden at the Kaljulaid seminar tomorrow. She has also been talking to an Estonian journalist about these topics.

Line and her colleague are scheduled for a 10 min talk each. Her colleague will talk about a project about "before and after the consent law" in denmark. Line will talk about how the consent law has affected the patients at the SAC (sexual assault center).

Finland

Here they have had a small increase in number of cases all over the country after the consent law was introduced. Riina has started to write a manuscript about this.

Faroe island

Diana has currently lost her fundings for SAC clinical work. This has been a cooperation between the hospital and the police. This has led to a new start with a new nurse's team, new phone numbers, information and more. A lot of extra work for Diana.

Greenland and Iceland?

Bjarne has been in contact with Greenland, they do not have any SAC or team for adults yet, only for children. Adults are only to contact their GP or community nurses, but none of these are specially trained in eg., forensic tasks. Bjarne will attend a new meeting with Greenland in November.
